Simple set-up


Both counterparts agree to the cash being invested into MMFs at the negotiation stage. The service supports MMFs on the Vestima platform selected in advance by both parties who specify the fund promoter, fund name, ISIN and

currency in a one-off subscription document. Clearstream will be able to issue the subscription orders on Vestima using a power of attorney.

Redemption and dividends

Dividends accrue daily but are paid, as with other funds, at the end of the month. Clearstream handles the dividend payments and reports to participants on a monthly basis.
