#### Information for T2S Releases 1.3.1 and 1.3.2

With this information, Clearstream Banking AG, Frankfurt<sup>1</sup>, would like to provide the latest status update on the T2S Release 1.3.1 deployment activities and the initial information about the upcoming T2S Release 1.3.2.

Please find below the implementation time lines for both T2S releases:

# T2S Release 1.3.1 Deployment date 18 November 2017 - Business day 20 November 2017 T2S Release 1.3.2 Deployment date 17 February 2018 - Business day 19 February 2018

Attached to this information, customers will find two files that show the most recent information about the related Problem Tickets (PBIs) for T2S Release 1.3.1 and 1.3.2. Customers are recommended to validate these items and check whether operational and/or functional modifications in their procedures are needed. Please note that these files contain only items that might have impact on CBF customers acting in ICP and/or DCP mode.

#### T2S Release 1.3.1 - Status update

The implementation of the software will take place during the weekend within the T2S maintenance window that starts at 03:00 on the Saturday morning. Meaning that no changes in T2S Operational Day are expected; neither for the end of day ("EoD") procedure on Friday, 17 November 2017 nor for the start of the business day Monday, 20 November 2017.

Four more T2S Problem Tickets (PBIs) with impact on CBF customers received priority. They have been added to the scope of T2S Release 1.3.1 and are authorised for the deployment weekend. Please note, that on 9 November 2017, the CSD Steering Group (CSG) will take a final decision on the implementation of the T2S Release 1.3.1. If a "No-Go Decision" is made, CBF will inform its customers at short notice.

The list below shows the newly added PBIs, only. CBF customers are recommended to validate these items and check whether operational and/or functional modifications in their procedures are needed.

(D17044)" are ready for delivery during the deployment weekend starting on 17 November 2017. Additionally, the CBF Customer Readiness Plan giving an overview of important milestones until the end of 2017, which was published in the same announcement, remains unchanged (please refer to the appendix). The customer simulation will start on 23 October 2017 as announced in the "CBF Customer Simulation for T2S Release 1.3.1 Notification".

This information will provide additional information about:

- Format and structure of the additional fields that will be added in the KUSTA Data Carrier "CBF Customers";
- The lasted customer simulation schedule in the time frame between 23 October 2017 and 17 November 2017.

#### **KUSTA Data Carrier "CBF Customers"**

The announcement <u>D17044</u> shows the modifications related to the KUSTA Data Carrier "CBF Customers". CBF customers requested to add a flag for the "Legal Entity Identifier" (LEI) and would like to see an indicator whether the CBF customer is set up to accept against payment instructions ("Teilnahme DvP").

Please find below the format for these fields which will be added as number 30 and 31 in the current structure. The existing filler will be reduced accordingly. The entire description of the format /structure after the deployment of the Release November 2017 can be found in announcement D17044.

#### Customer Simulation Schedule for T2S Release 1.3.1

On 29 September 2017, CBF provided the "Customer Simulation for T2S Release 1.3.1 - Customer Simulation Notification". This document outlines the scope of the simulation, describes the dedicated test cases and the schedules that are applicable during the simulation period. The simulation calendar was requested to be updated, because of the public holiday in Luxembourg on 1 November 2017 and an extended maintenance window on 10 November 2017.

The following calendar covers the entire customer simulation period for the T2S Release 1.3.1 from 23 October 2017 to 17 November 2017. It shows the availability of the CBF Customer Simulation environment (IMS23), highlights the "CCP batch days" and dedicated test cases.

#### T2S Release 1.3.2 - Introduction

Based on the T2S Release Concept<sup>2</sup>, T2S will deploy with the release in February 2018 the resolution for various T2S Problem Tickets (PBIs). Currently, the Release 1.3.2 covers ten Problem Tickets. These items have received priority by the T2S Settlement Managers. Additionally, six Problem Tickets received the status "Candidate for T2S Release 1.3.2". These items are under investigation and can be authorised for the deployment. For the time being, the scope of T2S Release 1.3.2 is not finalizsed and further functional updates might be authorised. Updates on the scope that will be announced by T2S for the deployment date in February 2018 will be communicated to customers in due time.

The first assessment related to the deployment activities by T2S shows, that the announced fixes will not require software changes in CBF. Irrespective of whether CBF has to modify its software, CBF will maintain its link to the T2S Pre-Production Environment (UTEST) so that customers can test on their demand. The simulation activities will be conducted in a "free simulation mode". The already established static data for CBF accounts and the related connectivity settings in CBF customer simulation environment (IMS23) will still remain unchanged. If customers would like to execute test cases for T2S Release 1.3.2, the T2S Support team should be informed by 5 January 2018, latest. The team will help to identify ISINs and provide further information with regard to the corporate action processing (KADI) planned beginning of 2018.

Please note that during the customer simulation window, software fixes for the UTEST environment can be announced by T2S on short notice. This might have an impact on the timeline on Friday, that is, the "T2S Release Day" schedule will apply. Additionally, CBF will use Friday afternoons to maintain the customer simulation environment. Therefore, IMS23 will be closed from 14:00 on any Friday in January and February 2018.

It might contain the resolution of reported Q2 problems in production June The concept defines a testing period of eight weeks in UTEST; that is so CSD participants can execute their test cases for the upcoming deployment A "problem release" is planned for the third weekend in September This release brings the resolution of reported problems in production **Q3** The concept defines a testing period of two weeks in UTEST; that is September so CSD participants can execute their test cases for the upcoming deployment A "minor release" is planned for the third weekend in November This release bring the resolution of reported problems in production. It can potentially contain functional enhancements if decided by the 04 different T2S committees **November** The concept defines a testing period of four weeks in UTEST; that is so CSD participants can execute their test cases for the upcoming deployment
