We hereby undertake to notify Clearstream promptly upon receipt of any information that would render any statement in this certificate invalid, untrue, incorrect, inaccurate, outdated or incomplete.

We accept full responsibility in the case of any claims liabilities, damages, costs and expenses of any kind that may be incurred, notably in terms of additional taxes, interest thereon or penalties levied by tax authorities in connection with any payments made in reliance upon this certificate, including any additional information provided in connection to it.
