With regard to the above, we hereby acknowledge and agree that:

- All credit advices issued and/or collected from our side to support the reclaim of withholding tax bear express reference of Euroclear Bank participant ID corresponding to the Euroclear Bank participant ID mentioned on Clearstream’s credit advice (if applicable);
- In case the withholding tax is refunded by the Irish Tax Authorities directly on the cash account of the beneficial owner, we undertake to inform Clearstream immediately after the receipt of the funds by the beneficial owner. Additionally, we acknowledge that Clearstream reserves the right to stop the service if we fail to comply with this undertaking in a repeating manner;
- The tax reclaim service offered by Clearstream and by the agent for the Dividend may be subject to changes depending on the Irish Tax Authorities requirements.
- Neither Clearstream nor the agent guarantee the acceptance of the reclaim or payment of the refund by the relevant Tax Authorities;
- Clearstream shall not at any time be held liable for any loss or damage caused by the tax reclaim procedure and shall be held harmless in respect of any liability arising from any action taken in relation to the tax reclaim procedure.
- We assume full responsibility for the accuracy, completeness and validity of the information contained in this Letter of Request or any attached document related to the above-mentioned refund requests on the Dividend and will hold Clearstream harmless for any claim or liability in relation to the content of this Letter of Request or of any attached document related to the above-mentioned refund requests on the Dividend;
- Signing this Letter of Request does not guarantee a tax refund.

This Letter of Request is governed and construed in accordance with the laws of the Grand Duchy of Luxembourg (for Clearstream Banking S.A. clients) and Germany (for Clearstream Europe AG clients using Creation accounts) and the courts of Luxembourg (for Clearstream Banking S.A. clients) and the courts of Germany (for Clearstream Europe AG clients using Creation accounts) shall have exclusive jurisdiction for all legal proceedings relating thereto.
