

**Power of Attorney for Tax Reclaim Processes Follow-up – dividends paid with record date on or after  
11 July 2022**

and with the necessary powers to do so, hereby confer all powers necessary, according to the law, in favour of **Clearstream Europe AG**, a limited company, with registered office at Mergenthalerallee 61, 65760 Eschborn, Germany, and registered in Register B of the Amtsgericht Frankfurt am Main, Germany under number HRB 7500 ("Clearstream Europe"), as attorney, to execute, in our behalf, with the faculty of sub-delegation to a third party, all acts which are necessary and appropriate for the presentation to the Danish Tax Authorities of the requests of refunds of Danish withholding tax on income concerning dividends and interest payments in relation with shares and bonds or other debt certificates which we hold as beneficial owner.

We hereby authorise Clearstream Europe to, on behalf of the undersigned:

- a. Present the forms, via its Danish agent, **VP SECURITIES A/S** with CVR-number 21 599 336 and known as "Euronext Securities Copenhagen" and as "ES-CPH" (hereafter referred to as "Euronext Securities Copenhagen"), to the Danish Tax Authorities for the tax refund request and follow the procedures following such presentation;
- b. Follow all tax procedures of this nature;
- c. Accept all notifications, via its Danish agent Euronext Securities Copenhagen, from the Danish Tax Authorities relating to those tax procedures, including the requests for information, further clarifications;
- d. Receive, via its Danish agent Euronext Securities Copenhagen, the notification from the Danish Tax Authorities of the final decision of acceptance/rejection of the tax refund procedures;
- e. Receive, via its Danish cash correspondent bank, all payments due under such tax refund procedures;
- f. Perform any other acts that Clearstream Europe considers necessary and appropriate with respect to matters mentioned, even in the absence of explicit instructions from the undersigned, notwithstanding any applicable rules with regards to banking secrecy in respect of such transactions.

We further hereby acknowledge and agree that:

- The tax reclaim service offered by Clearstream Europe may be subject to changes depending on the Danish Tax Authorities requirements;
- Clearstream Europe is authorised to process the tax reclaim with full reliance on the information provided by the undersigned, without any requirement for Clearstream Europe to verify the authenticity, completeness, accuracy or correctness of any such information and documents; and
- Clearstream Europe does not guarantee the acceptance of the reclaim or its payment by the Danish Tax Authorities, therefore, in the absence of any negligence of Clearstream Europe, Clearstream Europe shall not be held liable; and

- Clearstream Europe shall not at any time be held liable for any loss or damage caused by the tax reclaim procedure described above unless there is any negligence or wilful misconduct on the part of Clearstream Europe, Clearstream Europe, however, shall not be liable for any indirect or unforeseeable loss, claim, liability, expense or other damage unless such action or omission constitutes gross negligence or wilful misconduct on the part of Clearstream Europe.

We hereby warrant on a continuing basis that each of the signatories hereto and with respect to all documents submitted from time to time in relation to the tax reclaim procedure described above has full power and authority to sign on behalf of the undersigned.

We understand and agree that signing this Power of Attorney does not guarantee a standard refund of tax from the Danish Tax Authorities.

This Power of Attorney is valid until revoked by a written notice of revocation sent by \_\_\_\_\_

(Name of beneficial owner) to Clearstream Europe. Such notice of revocation shall take effect two (2) business days after receipt by Clearstream Europe. We hereby undertake to notify Clearstream Europe promptly in the event that any information contained in this Power of Attorney, or any documentation related to this Power of Attorney, becomes untrue or incomplete.

In the event that Clearstream Europe delegates any of its powers under this Power of Attorney to any third party, Clearstream Europe shall remain fully responsible for the acts undertaken or omissions committed by such thirdparty.

This Power of Attorney is governed and construed in accordance with the laws of Germany and the courts of Germany shall have exclusive jurisdiction for all legal proceedings relating thereto.
