We further acknowledge and agree that a fee will be charged by Clearstream Europe to our Account according to the stipulations of the appropriate Clearstream Fee Schedule.

With regard to the above, we hereby acknowledge and agree that:

- In case the withholding tax is refunded by the Swedish Tax Authorities directly on the cash account of the beneficial owner, we undertake to inform Clearstream Europe immediately after the receipt of the funds by the beneficial owner. Additionally, we acknowledge that Clearstream Europe reserves the right to stop the service if we fail to comply with this undertaking in a repeating manner;
- The tax reclaim service offered by Clearstream Europe and by the agent for the Security may be subject to changes depending on the Swedish Tax Authorities requirements;
- Neither Clearstream Europe nor the agent guarantee the acceptance of the reclaim or payment of the refund by the relevant Tax Authorities; and
- Clearstream Europe shall not at any time be held liable for any loss or damage caused by the tax reclaim procedure and shall be held harmless in respect of any liability arising from any action taken in relation to the tax reclaim procedure.

We assume full responsibility for the accuracy, completeness and validity of the information contained in this Letter of Request and will hold Clearstream Europe harmless for any claim or liability in relation to the content of this Letter of Request.

We hereby warrant on a continuing basis that each of the signatories hereto and with respect to all documents submitted from time to time in relation to the Security has full power and authority to sign on behalf of the client of Clearstream Europe mentioned below.

We understand and agree that signing this Letter of Request does not guarantee a tax refund.

This Letter of Request is governed and construed in accordance with the laws of the Grand Duchy of Luxembourg (for Clearstream Banking S.A. clients) and Germany (for Clearstream Europe AG clients using Creation accounts) and the courts of Luxembourg (for Clearstream Banking S.A. clients) and the courts of Germany (for Clearstream Europe AG clients using Creation accounts) shall have exclusive jurisdiction for all legal proceedings relating thereto.
