On 21 November 2011, Clearstream Banking<sup>1</sup> will implement a number of changes for services delivered via CreationConnect. Impacted media channels include Creation via SWIFT, CreationDirect and CreationOnline.

This Release Information presents the details of these changes to enable customers to make any required changes and to take advantage of enhanced products and services.

The summary of changes related to the SWIFT Standards Release 2011 were published, together with quality enhancements, in CBL Announcement A11066, dated 23 May 2011, and in the Creation via SWIFT User Guide November 2011 pre-issue, dated 30 June 2011.

The respective documentation and guides associated with the impacted products and/or services will be updated for the enhancements in due course.

**Note:** In some cases, this document will not contain the details of enhancements where a separate announcement has been published to address the needs of a particular product or service.

## 1. Executive summary

Effective Monday, 21 November 2011, as part of Clearstream Banking's ongoing commitment to the timeliness and quality of our services to customers, CBL will implement the mandatory SWIFT Standards Release 2011 together with quality enhancements requested by our customers.

The majority of the SWIFT changes concern messages for asset services with minor changes for settlement and reconciliation. The following messages will be impacted:

- Custody:
  - MT564 Corporate Action Notifications and Income Pre-Advice Report (IPAR);
  - MT565 Corporate Action Instruction;
  - MT566 Corporate Action Confirmation;
  - MT567 Corporate Action Status and Processing Advice;
  - MT568 Corporate Action Narrative;
- Settlement and Reconciliation:
  - MT544, MT545, MT546 and MT547 Settlement Confirmations.

In CreationOnline, we will streamline access to reports generated by CreationDirect and SWIFT. Customers will also be able to improve efficiency for their pre-release cash and securities instructions by making use of the new instruction file uploads.

The convenient Custody, Corporate Action respond upload feature for pre-release instructions has been expanded to provide new fields for beneficial owner details.

Users of Financial Instrument queries in Reference Data will now be able to download Terms and Conditions directly in CreationOnline.

Also, a new demo version of CreationOnline will assist customers in becoming more familiar with the extended range of business functions in the application.

## 2. SWIFT summary of changes

As published in CBL Announcement A11066, dated 23 May 2011, we will implement changes to our customer reporting that will enable:

- Greater granularity of information;
- Improved operational efficiency, with new event codes; and
- Increased clarity, with new qualifiers and greater consistency in the treatment of the sequence of corporate action options.

The changes are in part related to the SWIFT Standards Release 2011 and also in response to quality enhancements requested by customers.

The majority of enhancements concern the SWIFT messages for asset services with minor changes for Securities Settlement and Reconciliation.

Associated updates will be reflected in CreationOnline functions and CreationDirect reports. A CBL SWIFT User Guide pre-release has been published detailing the changes for individual messages.

### Asset Services

Our November 2011 Release for Asset Services messages will combine SWIFT Standards Release 2011 changes, improvements to comply with SMPG recommendations and enhancements requested by our customers.

For additional details of the formats by event type, please refer to the templates published in the Corporate Actions section of the SMPG website at [www.smpg.webexone.com](http://www.smpg.webexone.com), under Corporate Actions / Market Practices / Final global Documents / CA Event Templates SR2011.

SWIFT message formats will be enhanced or adapted as described in [Appendix B](#).

## Highlights of the changes

The changes we will implement in Asset Services are as follows:

- To minimise processing risk and in recognition of the increased complexity of Corporate Action events, deadlines will be defined at option level (Sequence E - CAOPTN).
- STP with Dutch Auction (DTCH) event coverage, previously reported as CAEV//0THR, will be improved.
- Reporting of event types PCAL (Partial Redemption with Reduction of Nominal Value) and PRED (Partial Redemption without Reduction of Nominal Value) will be improved. The last redemption of a bond partially redeemed via PCAL or PRED will, in line with SMPG guidelines, be reported via a REDM (Final Redemption) event or via MCAL for an early final maturity.
- Reporting of events with an early deadline and an early solicitation fee will be improved. Where an incentive is offered for customer response within an early deadline, CBL will provide one option for the early deadline and one for the standard deadline to enable better instruction management.
- Corporate Action Notifications will be enhanced to show all movements of securities and cash related to an event. As a consequence, subsequences E1 Securities Movements and E2 Cash Movements will show debits for securities and cash respectively.
- In response to customer requests, the coverage of fields has been extended and the IPAR will include many new fields to better align the content with Corporate Action Notifications.

## 3. CreationOnline

Significant enhancements will be made in CreationOnline to improve efficiency:

- New report retrieval facility: expanded View Reports, queries and downloads for customers' scheduled messages and reports from Creation via SWIFT and CreationDirect;
- Bulk Cash and Securities instructions upload facility with new CSV instruction files;
- Respond upload instruction files for Corporate Actions will now include beneficial owner fields;
- Upload list of securities to be included in the Corporate Action Reference Data Report;
- Retrieve Terms and Conditions on Financial instruments in either CreationOnline or CreationDirect;
- Use of regional settings for CSV file export functions;
- New, interactive demo version of CreationOnline.

### Streamline access to reports in CreationOnline

In November 2011, Clearstream Banking will offer customers new services to simplify their access to reports via CreationOnline, regardless of the media for which they were originally scheduled. The enhanced CreationOnline functions will enable the user to search, view and or download all scheduled Creation via SWIFT messages and CreationDirect reports (ISO, PDF, XML & CSV formats) in addition to the CreationOnline HTML reports.

#### Key features

- Scheduled reports from CreationDirect and SWIFT are accessible via CreationOnline;
- Report groups are removed;
- New View Report permissions enable users to view scheduled reports;
- Enhanced Query to retrieve reports.

#### Customer benefits

- Simple access in CreationOnline to retrieve reports from all media channels ;
- No longer necessary to access different applications to review reports.

#### Detailed information

The changes associated with the new report features are described in following subsections.

##### Removal of report groups

The Report Groups concept has been abolished in CreationOnline.

This removes the previous condition that if a scheduled report was not allocated to a report group, then that report was not retrievable. With the removal of the report group function, the associated alerts for report groups will be discontinued.

Existing report groups will be removed at cutover and replaced with new permissions for viewing reports. After the implementation date, user access to view reports will be defined by the OU Administrator.

##### Permissions to View reports

The OU Administrator will assign business user and business supervisor permissions to view reports for the business services allocated to Securities, Cash, Custody, Tax and Collateral reporting. The OU Administrator may activate the View Reports permissions by opening User Management/Users (or User Groups) /User permissions/View Reports.

## View Reports Query

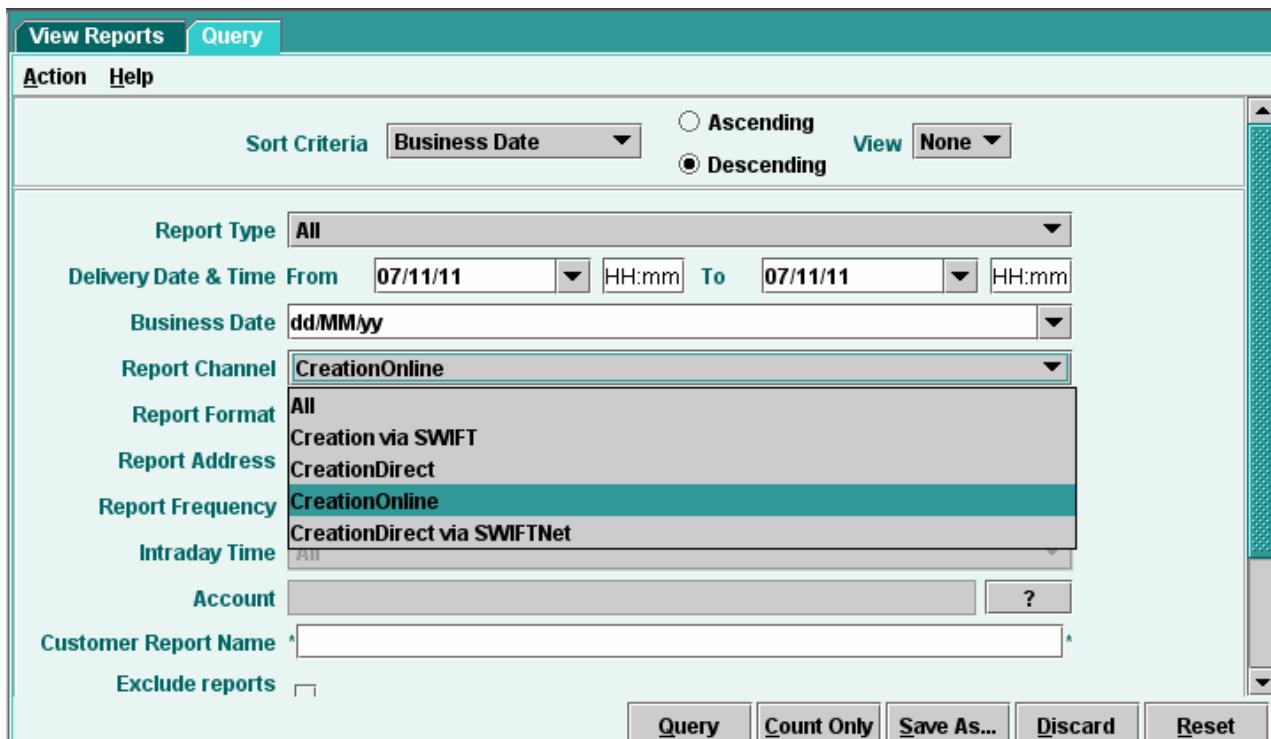
Users will be able to query, view and/or download scheduled reports and messages from all media channels, as follows:

- From CreationOnline: in HTML or CSV format;
- From CreationDirect (via VPN, via Internet, via LiMa): in ISO, XML, PDF and CSV formats;
- From CreationDirect via SWIFT (SWIFTNet FileAct): in ISO, XML, PDF and CSV formats;
- From Creation via SWIFT: in ISO format.

The View Reports Query will offer more detailed criteria to enable you to retrieve and display reports:

Report date, report type, channel, frequency, intraday time, format and address.

One or more accounts can be selected for the Account field.

A checkbox will enable users to exclude reports already downloaded via CreationOnline from query list view results. The default value will be unchecked such that all reports will be displayed by default in the query results.

Reports that have expired or have been removed from schedules will remain accessible in the history for up to 13 months (for monthly/quarterly/annual reports) and eight weeks (for the other reports).

Accumulation of the historic reports will begin as of production date, 21 November 2011, and will not cover earlier time periods.

**Note:** The retention period for HTML reports has been aligned accordingly and will be the same as for the other report types.

## View Reports List view

New columns will be added to indicate the channel, address and downloaded status for the report. The Downloaded box will be checked in the list view if the user has downloaded the report previously. There is no limit on the number of times an individual report can be downloaded.

From the View Reports List View, select Action “download” to save your report locally to your own computer or network drive.

Reports from any connectivity media channel, scheduled with either XML, ISO or PDF formats, can be downloaded in their original format.

Reports scheduled for CreationOnline may be downloaded in either HTML or CSV format or viewed and sorted, as today.

## Fees

View Reports queries will remain free of charge. There will be no extra charge for the report views or downloads via CreationOnline. Charges for reports will continue to apply according to the CBL International Fee Schedule.

## Improve instruction efficiency in CreationOnline for pre-release instructions

To promote instruction efficiency in CreationOnline, customers world-wide may elect to upload a list of up to 300 cash or securities instructions with an ASCII CSV file.

### Key features

With the new upload feature for cash and securities instructions, it will be possible to create new pre-release instructions as follows:

- Internal, Bridge and Domestic clearing and settlement instructions:
  - Receive Free (MT540)
  - Deliver Free (MT542)
  - Receive against payment (MT541)
  - Deliver against payment (MT543)
- Clearstream Banking Cash instruction types 10, 90, 9E and 9X:
  - Withdrawal of funds (MT103/MT202)
  - Foreign exchange (MT299)
  - Pre-advice of funds, single customer transfer (MT103/MT210)

Customers can create their own ASCII instruction files or make use of Clearstream Banking's automated Excel templates, which include an embedded macro to create the instruction file in the required format and field order. These templates will be available on the Clearstream Banking website.

### Customer benefits

Large number of cash and securities instructions can be created efficiently in CreationOnline using a simple format.

### Detailed information

#### Create instruction file

To make use of the instruction upload feature for Cash and Securities pre-release instructions, users will need to create an ASCII CSV file containing their instructions.

This is done in either of the following ways:

- Users employ the Clearstream Banking Excel templates with macros to create the instruction file with the correct field order and format. Clearstream Banking has created one Cash and one Securities Excel template that can accommodate a range of instruction types.

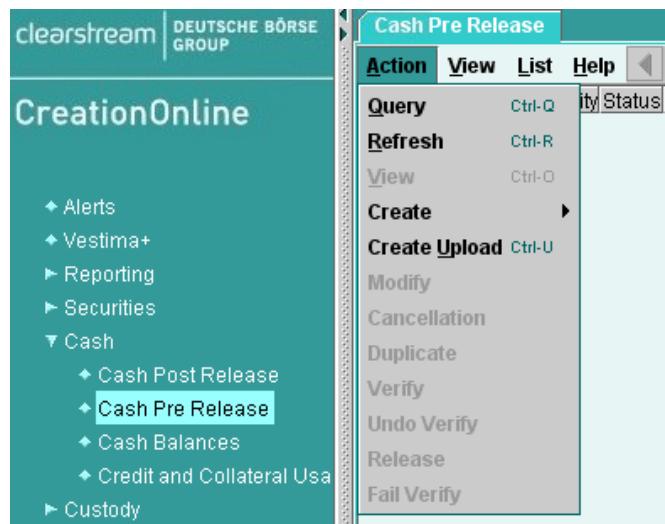
Each Excel template will contain three worksheets:

  - “User Guide” to describe how to use and customise the template.
  - “Instructions Data” for the input of the data in the selected fields for the instructions to be created.
  - “Fields” containing a list of all the available fields for the instruction file, guidance on the mandatory elements and space to define any default values for your instruction file. The user's regional settings will determine the file preferences for decimal and thousand separators.
- Users create the instruction file themselves, using the detailed field and format specifications indicated in the Appendix of this document. The file must be an ASCII text file, with any name or extension.

As of the release date, you will be able to access the instruction templates at [www.clearstream.com](http://www.clearstream.com), under Information Centre / Connectivity.

When the Excel template is complete and all the instructions have been added, simply click on the “Create Instruction file” button at the top of the Instructions Data worksheet. The file created by the Excel macro will be saved to the directory in which the template is saved.

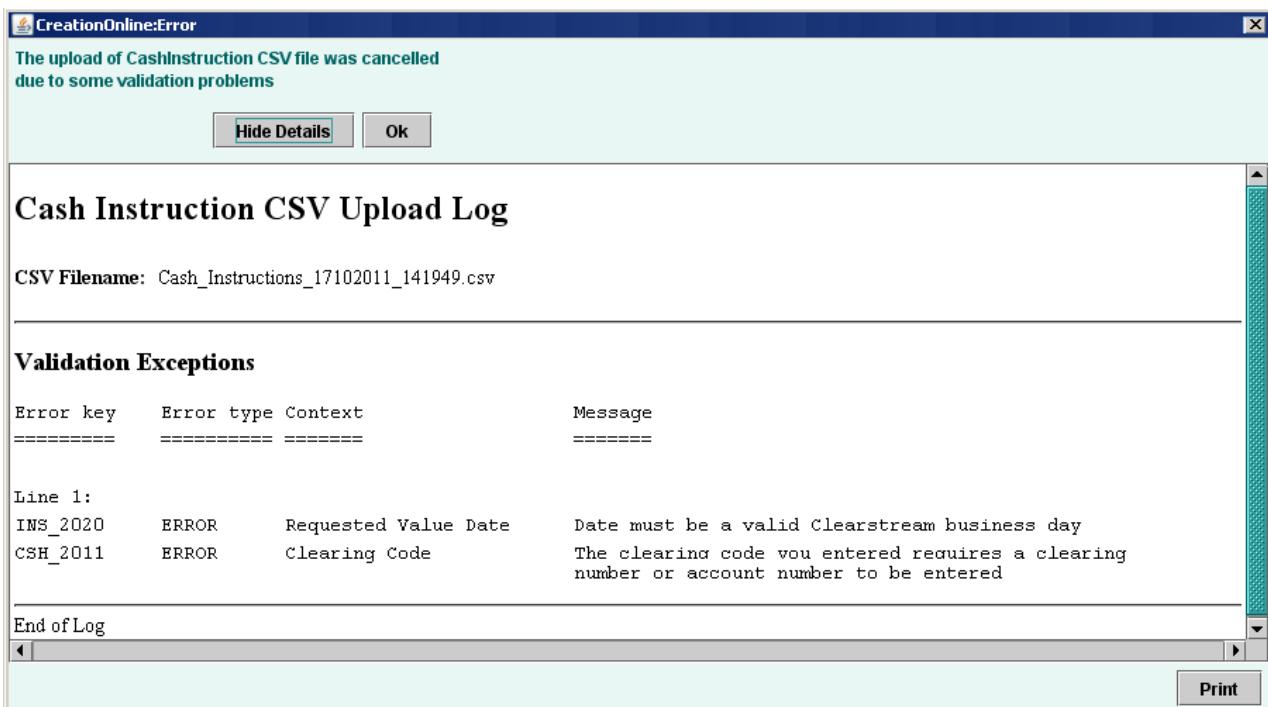
## Create upload



To upload your instructions, you must:

1. Log into CreationOnline.
2. Select Cash / Cash Pre Release or Securities / Securities Pre Release from the navigation bar.
3. Using the Action command, select "Create Upload" and you are prompted to browse for the file and then upload it from their system.

The upload process for the instruction file will generate feedback, either confirming acceptance of the whole file or rejecting it. If one instruction fails, the whole file is rejected. If the file is rejected, an online printable error message will highlight the problems that need to be fixed in the file before it can be reloaded.



## Release Information

After a successful upload, individual pre-release instructions will be created in CreationOnline. The users must “refresh” their pre-release list view to see these new instructions. From CreationOnline, the customer then applies either two- or four-eyes principle to these instructions.

CreationOnline will **not** check for duplicate instructions from different files.

Changes to the individual instructions created by the file upload can be performed directly in CreationOnline using the Modify or Cancellation functions. It is not possible to amend, cancel or overwrite these pre-release instructions with an instruction file upload. Further validations will be performed in CreationOnline on each individual pre-release instruction as if they were manually created and they will move through the existing status life cycle.

The instruction file that is used to create the pre-release instructions will not be saved in CreationOnline. To keep track of the file upload, a new audit event “Upload of Cash / Security CSV instruction file” will be created.

## Cutover

Permissions for the file uploads will be granted to all users who already have permission for Cash and/or Securities instructions input.

## Fees

No separate charges will be incurred for the use of the Excel templates or the upload of the instruction file. Charges are only incurred, according to the published CBL International Fee Schedule, for each pre-release instruction that is released in CreationOnline, as today.

## Custody/Corporate Actions pre-release instructions

For corporate actions, the convenient “Respond Upload” function, used to provide responses to corporate action notifications with an ASCII CSV file, will be expanded to include additional fields for beneficial owner details.

### Key features

The current functionality for the respond upload feature for a Corporate Action event enables the customer to utilise the details for a corporate action event to create a list of Corporate Action instructions.

With the November release, fields for beneficial owner details have been added to the instruction file. Due to the nature of the file, one instruction can contain details for only one beneficial owner.

Customers should be aware that, in order to continue to make use of the respond upload function, they will have to use the **new file format** to submit up to 100 instructions per file.

### Customer benefits

- Respond to corporate action events with multiple options and/or a high number of individual instructions;
- New, user friendly Excel template, including User Guide, instructions data and fields in the worksheet.

### Detailed information

#### Create instruction file

To make use of the respond upload feature for Corporate Action pre-release instructions, users will need to create an ASCII CSV file containing their instructions.

This is done in either of the following ways:

- Users create the instruction file themselves, using the new updated field and format specifications indicated in the Appendix of this document. The file must be an ASCII text file, with any name or extension.
- Users employ the Excel templates with macros to create the instruction file with the correct field order and format. Clearstream Banking has created a new Corporate Actions template; the old templates are now obsolete and will no longer be usable.

As of the release date, you will be able to access the revised Corporate Action instruction templates at [www.clearstream.com](http://www.clearstream.com), under Information Centre / Connectivity.

When the Excel template is complete and all the instructions have been added, simply click on the “Create Instruction file” button at the top of the Instructions Data worksheet. The file created by the Excel macro will be saved to the directory in which the template is saved.

#### Respond-Upload

To upload your instructions, you must:

1. Log into CreationOnline.
2. Select Custody - CA Notification from the navigation bar.
3. Identify the instruction you want to respond to (CA notification Queries, list view or CA notification detail view).
4. Select Respond-Upload from the Action menu or right-click on the appropriate notification in the list and select Respond-Upload from the pop up menu.

The user is then prompted to browse for the file and upload it from their drive.

The upload process for the instruction file will generate feedback, either confirming acceptance of the whole file or rejecting it. If one instruction fails, the whole file is rejected. If the file is rejected, an online printable error message will highlight the problems that need to be fixed in the file before it can be reloaded and sent.

After a successful upload, individual Custody pre-release instructions will be created in CreationOnline. The users must "refresh" the session in order to see these new instructions. From CreationOnline, the customer then applies either two- or four-eyes principle to these instructions.

CreationOnline will **not** check for duplicate instructions from different files.

Changes to the individual instructions created by the file upload must be performed directly in CreationOnline using the Modify or Cancellation functions. It is not possible to amend, cancel or overwrite these pre-release instructions with an updated instruction file upload. Further validations will be performed in CreationOnline on each individual pre-release instruction as if they were manually created and they will move through the existing status life cycle.

## Cutover

Existing Corporate Action instruction files used by the customer must be updated to include the new file specifications and regional settings rules or they must be replaced by files created with the new Corporate Actions template.

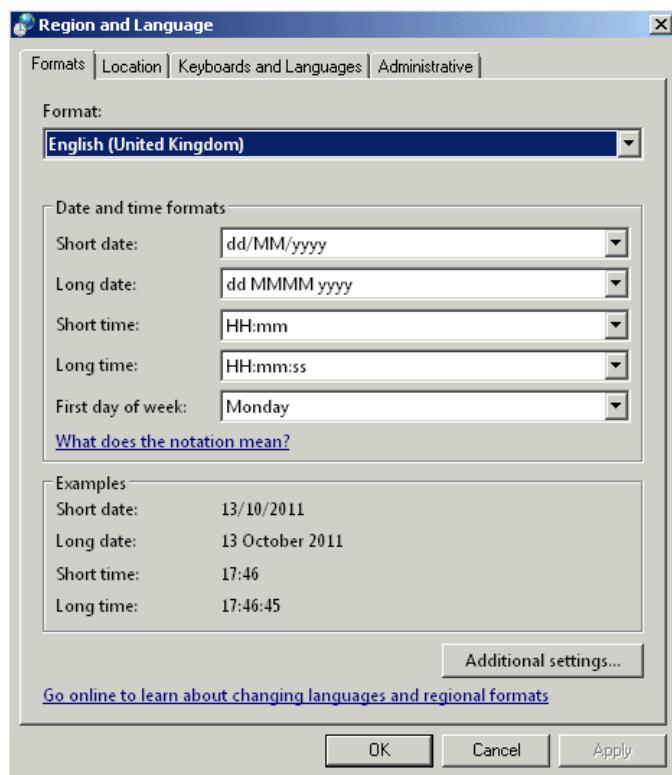

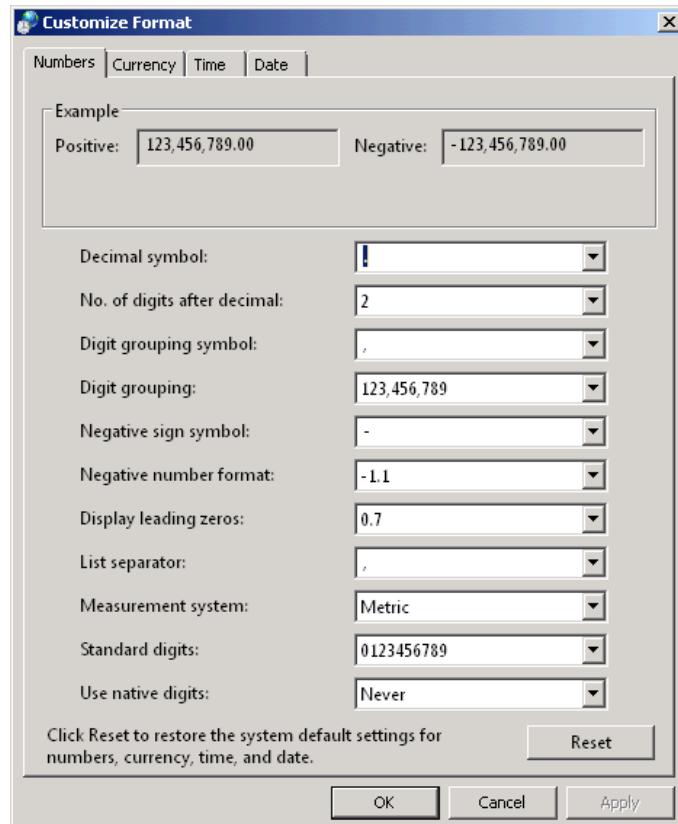

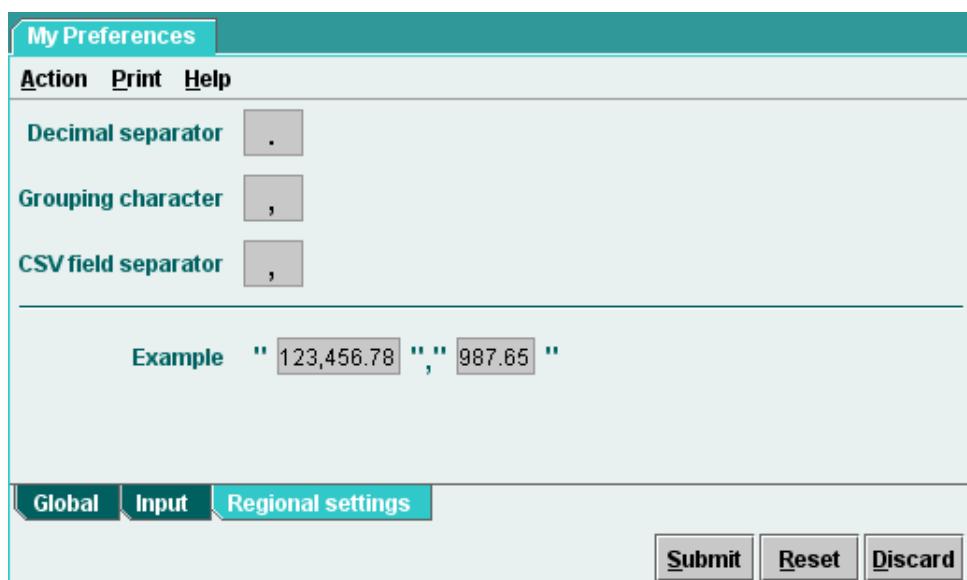

## Impact on the customer

CSV files created with the export functions before November 2011 may have been saved using a different CSV field separator or number formatting than would be applied using the rule of the local settings.

For example, the previous separator was always a comma; now, based on German regional settings, the field separator will be a semicolon.

Using the rule of the local settings for the CSV files will allow the user to open the CSV file in Excel as Excel expects the file to be, in line with the user's regional parameters.

The same local settings will be verified when uploading CSV pre-release instruction files: If the CSV file is not compliant, it will be rejected as there is a risk of misinterpreting a number.

For example, 1,001 could be read as "one thousand and one" or as "one point zero, zero, one.

CreationOnline safeguards against this mistake by checking all numbers against the number format of the user's regional parameters.

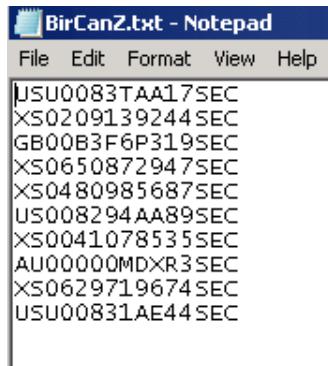

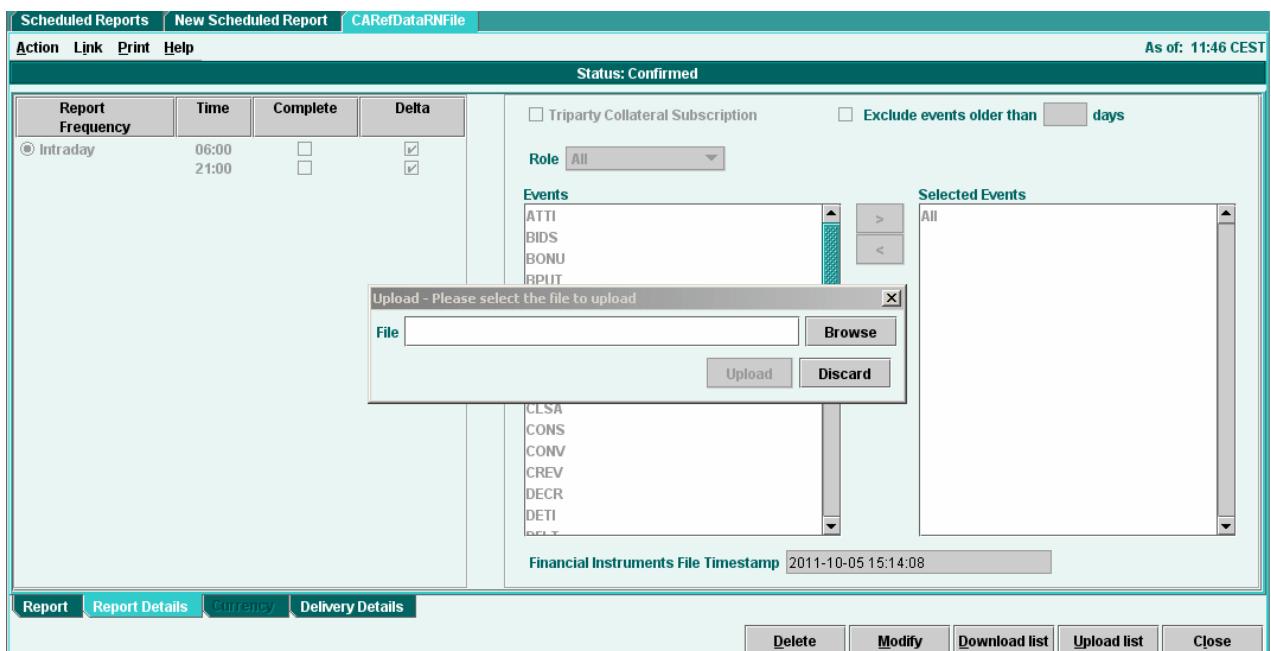

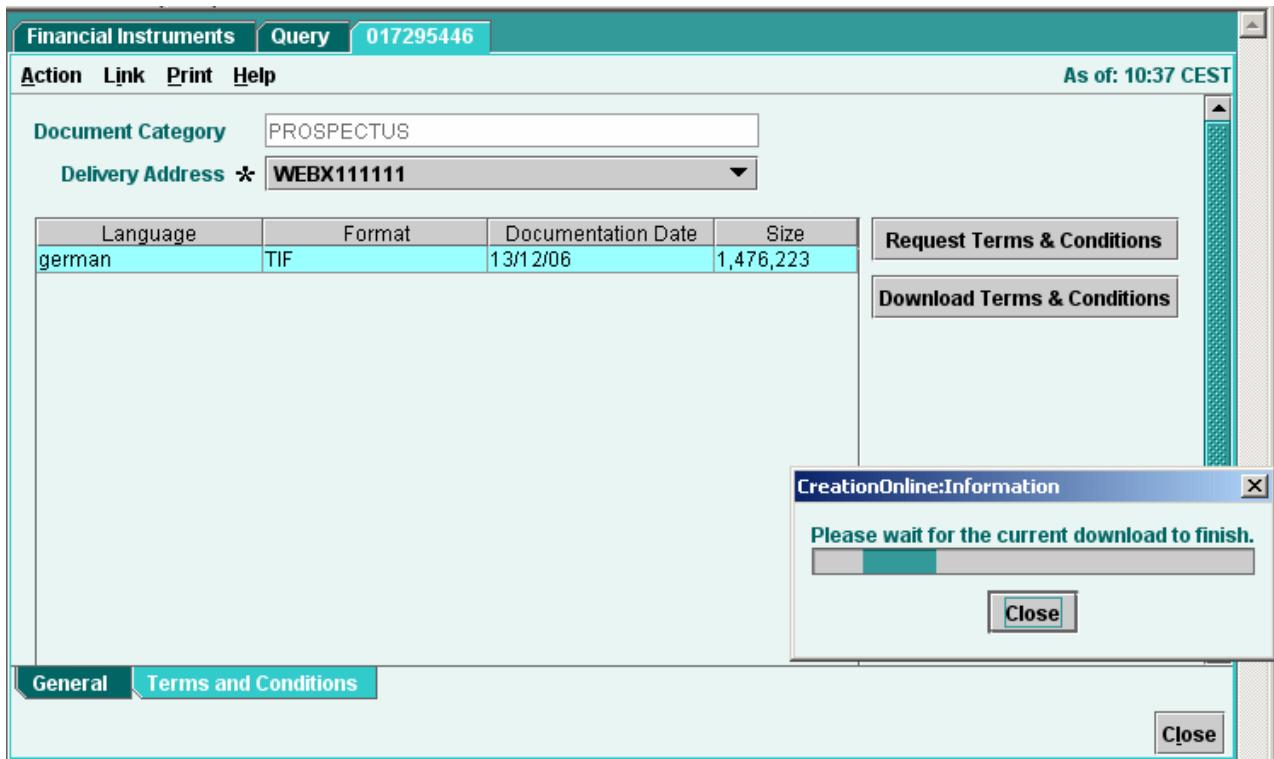
