1. Purpose

The subscribers to this form hereby represent and warrant that they have the power and authority to enter into this Subscription Agreement. This agreement hereby binds the parties to the rules and procedures as applicable in connection with the EPIM service and as amended or supplemented from time to time.

The provision of the EPIM service shall start after CBL has received this Subscription Agreement and any additional documentation CBL may require, as of the date that CBL shall communicate to the subscribing Participant ("Starting Date").

Note: All EPIM messages sent or received with a test flag will be solely used for testing the system and cannot be used for any other purposes.

2. Confidentiality

Except for the strict purpose of establishing and using the EPIM service, each party shall treat the information received from the other party as strictly confidential. This provision shall survive the termination of the service.

3. Responsibility

CBL undertakes to perform its duties in accordance with these Terms and Conditions and the terms of the GTCs.

CBL shall not be responsible for any action taken or failure to take any action as a result of events beyond CBL's reasonable control.

4. Governing law

These Terms and Conditions shall be governed by, and shall be construed in accordance with, the laws of Luxembourg. Matters not expressly provided for in these Terms and Conditions shall be governed by the applicable provisions of Luxembourg law. The Customer submits to the exclusive jurisdiction of the competent Luxembourg courts for any litigation which may arise.

5. General Terms and Conditions of CBL

Unless otherwise expressly provided in these Terms and Conditions, the Customer hereby expressly submits to CBL's General Terms and Conditions and any other Governing Documents (as defined therein) ("GTCs"). The Customer acknowledges receipt of a copy of CBL's GTCs.
