## Failed Trade/Settlement Reporting

Once the trade is executed on approved trading platform, there is no ability for the onshore dealers (BCMMs) or offshore counterparty (Bond Connect Investor) to cancel or modify the trade. Any trades that are executed and failed to settle are subject to settlement failure reporting per PBOC and CFETS requirement. Following are quick summary of the settlement failure forms and timeline for filing. These forms are also available in the appendix.

For late filing as long as the investor has legitimate reason, BCCL will assist to provide explanation to CFETS. PBOC and CFETS will determine whether to impose penalty on case by case basis.
