1. INTRODUCTION

These specifications are for Comma Separated Value (CSV) files; the fields are separated by commas. Each line in the file represents a record, and records must be terminated by line feeds (carriage return). The number of commas per record must remain consistent with the record lay-out. The file must be compatible with ANSI character set encoding.

Any file name extension other than ".ISO" can be used (including none at all), but compressed files need to use the extension ".ZIP" or ".GZ" to allow automated processing. Senders are advised to include a unique identifier (such as a date or serial number) in their file naming convention, to simplify tracking and error reporting.

1.1. NUMERICAL DATA

A full stop (.) must be used as decimal separator. The maximum lengths of numerical fields defined herein refer to the number of digits (integers and fractions) excluding any decimal separators. Signed values are not allowed; all quantities, amounts, prices and sums must be expressed as positive values without any sign. The totals to be put in the trailer record are only there for technical validation of the data integrity and have no business purpose.

1.2. REFERENTIAL AND TEXT DATA

The literal values specified for the fields RECORD TYPE, STATEMENT TYPE, STATEMENT FUNCTION and RECEIVE/DELIVER INDICATOR must be filled verbatim in UPPER case and without any double quotation marks ("). The fields SAFEKEEPING ACCOUNT, SETTLEMENT REFERENCE and ALTERNATIVE REFERENCE can be filled using A-Z, 0-9, special characters

/ - +?.:() and space (however, only using space is not allowed).

1.3 STATUS COLUMN

In the specification tables below, the "Stat" column indicates the status of each field. The legend used is M for mandatory, O for optional and C for conditional. Optional and conditional fields that are not used must not contain any character, including space.

2.1. FILE NAME CONVENTION

The name of the CSV file must include the name of the sender (indicative name of the Transfer Agent) and the name of the file must finish with the following:
