- b) to receive from CEU all information of any kind on the status of the instructions transmitted by the Attorney.

This power of attorney shall remain valid until notice of revocation or amendment is received from the Company or, in the event of No. 2, from the Companies to CEU by Registered Letter. Any such revocation or amendment shall take effect on the second business day in Frankfurt after receipt of the notice by CEU or such other later date specified in the notice accordingly.

This power of attorney is governed by and shall be construed in accordance with the laws of the Federal Republic of Germany.
