- We hold exclusively EIS/EU Issuance debt securities on our account. We do not hold Belgian debt securities integrated into the National Bank of Belgium ("NBB") X/N system.

 We may hold from time to time Belgian debt securities in addition to EIS/EU Issuance debt securities on our account. We understand that Clearstream Banking operates an X account (exempt account) in the NBB's X/N system such that, from a fiscal point of view, all clients that hold eligible Belgian debt securities through Clearstream Banking must do so exclusively on behalf of beneficial owners (including themselves, if applicable) that qualify for exemption from Belgian withholding tax. We hereby acknowledge that, for the purposes of holding and obtaining the appropriate reduced rates, we must submit to Clearstream Banking, in addition to this document, the One-Time Certificate for Belgian Debt Securities integrated into the X/N system of the National Bank of Belgium (NBB) prior to the first settlement of these Securities.
