In order to apply for a refund based on the above-mentioned treaty rate, we provide Clearstream Banking, within the prescribed deadlines, with all required documentation, including but not limited to the official reclaim forms, duly completed by the beneficial owner and by its local tax authorities.

We acknowledge and accept that, according to the Clearstream Banking tax reclaim procedure, a full standard refund of withholding tax on income from Portuguese securities based on Portuguese domestic law is not available through Clearstream Banking.

With regard to the above, we hereby acknowledge and agree that:

- If withholding tax is refunded by the Portuguese Tax Authorities directly on the cash account of the beneficial owner, we undertake to inform Clearstream Banking immediately after the receipt of the funds by the beneficial owner.
